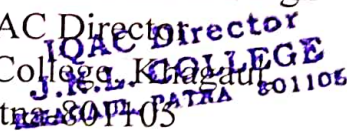

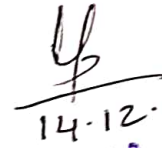



1. Purpose
