


1.PREAMBLE:

3. PRINCIPAL PLACE:

The principle Place of the Trust Shall be at J.N.L.College,khagaul Campus, However the Trust may Change the Principal place of office from time to time if

Required, Facilities & Accommodation required to run the office will be Provided by the Alma mater.

4. AREA OF OPERATION:

The Trust will operate over India.

- 5. Trust property & resources of the Trust:

- (v) Decide from time to time the works and projects of the trust.

9.TRANSACTION OF BUSINESS BY THE TRUSTEES:

- (iii)The Managing Trustee shall maintain a record of all the proceeding of the meeting.

Further no amendments shall be carried out without the prior approval of the commissioner of income Tax.

16. UTILIZATION OF INCOME:

The fund and income of the Trust shall be solely utilized for the achievement of its objective and no portion of it shall be utilized for payment to the Trustees by way of profit, interest, dividend or whatsoever.

17. BENEFITS OF THE TRUST:


