7. BOARD OF TRUSTEES:-

Trustee in his discretion for such tem as stipulated at the time of their of appointment . After the managing trustee ceases to be a trustee by retirement or otherwise, the vacancies on the Board of Trustee shall be filled in by a majority of the board trustees. The managing trustee on tis ceasing to be trustee of laying down the office of the managing trustee for any reason whatsoever, then trustees shall appoint one amongst them as managing trustee by a majority, for such period as may be stipulated at the time of appointment .the office of the managing trustee shall be honorary.

8. POWER OF THE BOARD OF TRUSTEES:

(iv) Prescribed from to the eligibility foe benefits provided by the Trust and to vast the Conditions for the same from time to time.

(v) Decide from time to time the works and projects of the trust.

9. TRANSACTION OF BUSINESS BY THE TRUSTEES:

(i) The Trustees may may meet as necessary for the conduct of Business of the Trust.

(ii) The quorum for meeting shall be 2/3.

(iii) The Managing Trustee shall maintain a record of all the proceeding of the meeting.

10. MANAGING TRUSTEE:

The Managing Trustees shall have the powers of managing the Trust and its Properties, sign documents, statements, affidavits, declaration, rerunsets. For the Trust, Appoint, transfer and terminate employee, open and operate Account and attend to the Day to day management of the affairs of the Trust. 15. AMENDMENTS:

The Trustees shall have the power by three fouthmanjorities to make Amends to the Trust deed as many be required for the smooth-functioning of the Trust from time to time. However, no Amendmesnts to the Trust deep shall be made which many prove repugnant to the provisions of section 29(15),11,12,and13 and 80 Gov of india the income Tax Act. As Amended from time. Further no amendments shall be carried out without the prior approval of the commissioner of income-Tax.

16. UTILIZATION OF INCOME:

The fund and income of the Trust shall be solely utilized for the achievement of its objective and no portion of it shall be utilized for payment to the Trustees by way of profit, interest, dividend or whatsoever.

17. BENEFITS OF THE TRUST:

The benefits of trust shall be open to all irrespective of caste, creed or religion.
